Neonatal Intensive Care Unit Rotation (NICU)**Literature Review Presentation (30 minutes)**

The fellow will identify a clinical topic of interest relevant to the intensive care of the neonate, and perform a literature review that culminates in a 30 minute presentation.

ECMO Course (1 full day)

The fellow will be required to attend a course on extracorporeal membrane oxygenation that will be funded by the division.

Perinatal Conference (60 minutes)

The fellow will be required to attend all scheduled perinatal clinical conferences.

Neonatal Resuscitation Simulation (1 half day)

The fellow will be required to attend a half day simulation course on neonatal resuscitation conducted by the Center for Advanced Pediatric Education (CAPE) at Stanford.

Pediatric Intensive Care Unit Rotation (PICU)**Literature Review Presentation (30 minutes)**

The fellow will identify a clinical topic of interest relevant to the care of the child, and perform a literature review that culminates in a 30 minute presentation.

Pediatric Advanced Life Support (2 full days)

The fellow will attend a PALS course, funded by the division.

Pediatric Surgery

Journal Club (60 minutes)

The fellow will be responsible for defining topics and administering the monthly pediatric surgery journal review seminars.

Quality Assurance Rounds (60 minutes) & Quality Improvement Committee

The fellow will present cases at the monthly pediatric surgery quality assurance (morbidity and mortality) rounds and review relevant issues. The resident is responsible for completing and presenting a practice-based improvement log for each morbidity/mortality case discussed.

The trainee will also be a member of the hospital's Performance Improvement Steering Committee which will expose the resident to a variety of quality planning and initiatives that contribute to knowledge of a systems-based practice. This committee meets monthly and is charged with monitoring of actual or potential patient care and service problems and processes; monitoring effectiveness of improvement teams; addressing utilization, length of stay, resource consumption, and admission and discharge processes. Minutes are generated and the Committee Chair will evaluate the resident bi-annually.

Surgery/Radiology/Gastroenterology/Pathology Combined Rounds (60 minutes)

The fellow will be responsible for organizing and presenting cases at the monthly combined clinical rounds.

Intestinal Rehabilitation Program Meetings (60 minutes)

The fellow will attend regularly scheduled meetings of the intestinal rehabilitation program to discuss the multidisciplinary care of children with short bowel syndrome.

Pediatrics & Surgery Grand Rounds (60 minutes)

The fellow will present once yearly at both the pediatric and surgical grand rounds.

Medical Student Lectures (60 minutes)

The fellow will give the regularly scheduled (6 times per year) lecture on pediatric surgery to the Stanford medical students.

Tumor Board (60 minutes)

The fellow will attend regularly scheduled meetings of the multidisciplinary oncology board.

Bariatric Surgery Review Board (60 minutes)

The fellow will attend regularly scheduled meetings of the multidisciplinary healthy weight and bariatric surgery board.

Practice Management Seminars (60 minutes)

The fellow will participate in the practice management seminar series that is currently offered to PGY5 general surgery residents. Seminar topics include *Preparing for Private Practice*, *Preparing for Academic Practice*, *Financial Planning for the New Surgeon*, *Avoiding Malpractice Litigation*, *Contract Negotiation*, and *Effective Leadership and Communication*.

Monthly Clinical Teaching Session (60 minutes)

When on Surgical Rotation, a member of the pediatric surgery faculty will give a monthly clinical teaching session to the housestaff that the fellow will attend. This session will be subject to both pre and post tests, in the spirit of the in-training exam.

NICU Seminar Series (60 minutes)

When on NICU rotation, the fellow will attend all scheduled didactic sessions schedule by the neonatology faculty.

PICU Seminar Series (60 minutes)

When on PICU rotation , the fellow will attend all scheduled didactic sessions schedule by the intensive care medicine faculty.

Surgical Grand Rounds (60 minutes)

The fellow will attend all the weekly scheduled surgical grand rounds.

Billing and Coding Seminar (120 minutes)

The fellow will attend the billing and coding seminar already in existence for surgical residents.

Responsible Conduct of Research Workshop (1 full day)

The fellow will participate in Stanford's responsible conduct of research workshop.

Lane Library Informational Technology Workshop (1 half day)

The fellow will participate in Stanford's Lane Library Online Research Tools Workshop that teaches efficient use of informational technologies available to members of Stanford's community (eg. Literature search tools, etc.).

Peer-Reviewed Journal Articles

The fellow will be required to generate 1 manuscript per year of clinical research that will be submitted to a peer-reviewed journal for publication.

Quality Improvement Chart Review

Once per year, the fellow will be required to identify 1 relevant clinical indicator of quality within the pediatric surgical practice and perform a chart review to determine the quality of care provided by the service.

Case Log

The fellow will keep a running case log of surgical cases as assistant surgeon, surgeon, or teaching surgeon, which will be reviewed on a quarterly basis to determine progress and address gaps in training.

Electronic Journal Library

By the end of the fellowship, the fellow will provide evidence of an electronic library of journal articles relevant to actual clinical problems they have encountered (minimum 10 topics per year).

Yearly Presentation at National Conference

The fellow will present once a year at a nationally recognized pediatric surgical conference.

Bi-Annual Self-Evaluation

Twice yearly, the fellow will submit and document in the portfolio a self-evaluation of progress in the fellowship using a Likert scale type of evaluation form rating the core competencies.

Ethics Presentation

The fellow will be required to give one slide presentation that discusses the issues surrounding an ethical dilemma relevant to pediatric surgeons.

The fellow is also required to complete an on-line ethics module given by the American College of Surgeons.

In-Training Exam (ABSITE)

Adequacy of medical knowledge will in part be assessed using the yearly in-training exam for pediatric surgery. The trainee is expected to score above the 50th percentile.

Oral Exam

A member of the pediatric surgery faculty will give a biannual oral exam to the fellow that will be formally evaluated, and the fellow will be provided with feedback on progress and gaps in learning.

360⁰ Evaluation

Adequacy of interpersonal communication and professionalism will be assessed by bi-annual 360⁰ evaluations of the pediatric surgery resident using nurses, peers, patients and their families.
